Penn State Extension – January 15-31, 2019 Events.

Penn State Extension – Toss Your Hat in the Ring –Peter Wulfhorst of Penn State Extension explains one of the programs listed in the schedule of events. Every four years is a County Election year and Penn State Extension does a workshop in counties to highlight and provide information on local government. A recent survey taken by a professor for the Center of Pennsylvania found that most local officials run unopposed or there isn't anyone running. Local government is the level of government that people interface most often with- school board members, township supervisors and local councils. We do a program called "Toss Your Hat in the Ring". It is being held on January 28, 2019 at the Blooming Grove Training Center from 7:00 PM-9:00 PM. We talk about different components and facets of local government from townships to school districts to the boroughs to positions like tax collector, constable, auditors plus the governing body. The cost is \$25.00 and the flyer has a link to the registration site. Monroe County is also doing one on February 7, 2019 at the Extension Office in Stroudsburg, PA.

Nadeen Manzoni of Pike County Elections will be giving an overview on how to run for office. She will be going over everything from how to circulate a nomination petition, how to get on the ballot, campaign finance, campaign finance reports will be available and so will various forms and petitions. People will have the opportunity to ask questions and at the end current, local, elected officials will be talking about their experience in local office. It is a great workshop for anyone considering running for office. All the materials needed to run for local office will also be available.

PRESS/PUBLIC COMMENT

Chris Jones of the Dispatch asked why some of the contracts do not need to go out for bid. Commissioner Osterberg responded that the amount is way below the amount of the bid threshold. That is the beginning of the roof projects and that was part of what the funding is for. The bids have already been put out to do the roofs on both buildings and that is the first step in the process.
