The first regular meeting of October, 2015 of the Pike County Commissioners was called to order by Commissioner Caridi at 9:00 a.m. at the Pike County Administration Building, followed by the "Pledge of Allegiance" to the flag. Father Paul Mullen of St. Vincent de Paul Church, Milford offered the opening prayer.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Wagner, to approve the October 7, 2015 Agenda.

**VOTE:** Commissioners Caridi, Osterberg and Wagner voted 'aye'. Motion carried.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Wagner, to approve the September 16 and 30, 2015 Commissioners' Meeting Minutes.
