## Wednesday, November 16, 2016

The second regular meeting of November 2016 of the Pike County Commissioners was called to order by Commissioner Osterberg at 9:00 a.m. at the Pike County Administration Building, followed by the "Pledge of Allegiance" to the flag. A Thanksgiving Prayer was offered by Pastor Eddie Panero of Calvary Chapel of Milford.

PRESENT: Commissioners Osterberg, Caridi and Guccini; Chief Clerk Orben; Solicitor Farley.

### Public Comments/Questions concerning today's agenda.

Michelle Newberry, recent Community Traffic Safety Program Coordinator through PennDot, has since been replaced by Christina Sullivan, who will be taking over Lackawanna and Pike Counties. Ms. Newberry was present to speak about Click it or Ticket, which is a border to border mobilization through PennDot especially through the holiday season. The seatbelt law is primary law for teenagers under the age of 18 and all of their occupants. If you are over 18, it is a secondary offense. The Click It or Ticket Mobilization is taking place through the beginning of December, and then starting in December is the DUI Enforcement. Flyers will be distributed shortly.

Mr. Ruiz thanked the Commissioners for the opportunity to work for Pike County. He gave a brief overview of his experience and education, and is excited to begin this new endeavor.

the Contract for Professional Services between Ray Evans and the County of Pike, for CDBG and HOME Programs Housing Rehabilitation Consultant Services.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to authorize the Chairman to execute the Contract for Professional Services between TCI Environmental Services and the County of Pike, for CDBG and HOME Programs Lead-Based Paint Evaluation Services. VOTE: Commissioners Osterberg, Caridi and Guccini voted 'aye'. Motion carried.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to reappoint Scott Savini as Farmer

Director and to appoint Kelly Stagen as Public Director on the Pike County Conservation District Board for a fouryear term ending December 31, 2020.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to reappoint Commissioner Richard A. Caridi as Commissioner Director on the Pike County Conservation District Board for a one-year term ending December 31, 2017.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to authorize the Chairman to execute the Acknowledgement and Consent Letter for Modification of Antenna Facilities between T-Mobile and the County of Pike, 135 Pike County Boulevard, Lords Valley.

VOTE: Commissioners Osterberg, Caridi and Guccini voted 'aye'. Motion carried.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to authorize the Chairman to execute the Memorandum of Understanding between the PA Department of Aging and the County of Pike, on behalf of the Area Agency on Aging.

VOTE: Commissioners Osterberg, Caridi and Guccini voted 'aye'. Motion carried.

Robin LoDolce, Area Agency on Aging Director, explained that this Memorandum of Understanding is for a Shared Housing Match-up Pilot Program for Pike, Wayne and Monroe Counties as a rural phase, with the hopes that the program will be successful and offered as an urban phase. Phase 1 of "SHARE" is designated to address an increasing need for affordable housing options for seniors and seniors with disabilities, and the desire for seniors to age in place and remain living in their homes and communities rather than an institutional setting. To begin the pilot, (first two years of funding) two full-time SHARE Housing Counselors, will watch homeowners with extra space in their homes with individuals seeking affordable housing in Pike, Wayne and Monroe, and will seek to expand the pilot area to surrounding counties during years three and four of the MFP funding. This program will help match senior homeowners (host) with home seekers (home sharer) of all ages, including other seniors, individuals experiencing homelessness, individuals transitioning out of nursing homes, and veterans, as well as match non-senior homeowners with senior home seekers.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to authorize the Chairman to execute the Addendum for the Laserfiche to PACSES Export Project between Atlantic Tomorrow and the County of Pike, on behalf of the Domestic Relations Office.

VOTE: Commissioners Osterberg, Caridi and Guccini voted 'aye'. Motion carried.

MOTION: by Commissioner Caridi and seconded by Commissioner Guccini, to authorize the Chairman to execute the Planned Maintenance Agreement between Cummins Power Systems and the County of Pike, as recommended by the Prison Board, on behalf of the Correctional Facility

VOTE: Commissioners Osterberg, Caridi and Guccini voted 'aye'. Motion carried.
